NPPD RRC/PRAB/Customer Meeting

Discussions held at the meeting, update on the performance of Cooper Nuclear, update on non-nuclear decommissioning study, update on the demand waiver program and legislative issues. McWhorter attached both the FERC order 2222 and the NPPD Non-Nuclear Decommissioning Cost Estimate study for the board to review.

Bancroft Sub

Working on getting trees planted. Customer still not happy with the new Substation. Board will go to the substation and discuss the issues with the customer in person.

Audit

The audit was completed, but Kari and Chet are not happy with the process of the audit. They will have a meeting with Eide Bailly to discuss the communication issues that they had this year.

NRECA Wind Study

NRECA is doing a case study on some systems that have wind projects like CCPPD. They wanted to include our power district for the study. Chet agreed to this, and they will provide the information as it becomes available.

Fairgrounds Sub T Reroute

Still working on the cost with the Fair Board. Last month, director Kaup asked Chet to inquire with our insurance if CCPPD would put underground in. McWhorter stated that there would not be an increase liability for underground. Looking at fall work and will continue discussions with the fair board.
