Directors' Expense and Reports

Director expenses were presented.

Director Kluthe inquired about three items on the Treasures report. Annual benefits for insurance and two promotional items that Nicki uses. He mentioned to Scott Haber that there is still static on Hwy 17 near the county line.

The board reviewed Scott Haber's recommendation for a new truck. The board was good with the truck that was decided on by the truck committee. They can purchase the vehicle.

Director Mostek had a customer ask if there would be ribbon cutting for the wind turbine. McWhorter will talk to Bluestem and see if we can find a time that would work but still follow the COVID guidelines.

Director Kaup asked that CCPPD look at ordering material in enough advance. He is worried lead times will be delayed with all the new stimulus money coming out. McWhorter told Kaup the Tisha Wilson has ordered many parts for future products because of the lead times. CCPPD will keep that in mind when looking at future projects.

Meeting Updates

NRECA Annual Meeting

General Manager Chet McWhorter, board members Leroy Mostek and Greg Strehle, along with CCPPD staff listen to George W Bush speak. He did well and everyone enjoyed his talk.

Manager McWhorter and director Strehle attended the other various meeting throughout the week. Meetings and discussions were held on Batteries, presented by Bluestem. Policies and resolutions, Keystone Pipeline, Economics in NRECA and the rolling blackouts that occurred in February.

Director Assignments

Director Strehle and Mostek will go to the NPPD Plan B in York on March $10^{\rm th}$. Director Mostek will attend the Nebraska G&T meeting on March $31^{\rm st}$ in Columbus.

McWhorter told the board they could attend the NPPD Customer and RRC meeting in Columbus on March $18^{\rm th}$.

Managers Expense & Report

Chet McWhorter had no expenses.

2022 85th Anniversary Celebration

Next year will be the $85^{\rm th}$ Anniversary at CCPPD. McWhorter asked the board if they would like to have a celebration. The board decided to think about it and will have an answer at the April Board Meeting.

Collection Calls

McWhorter was informing the board that in April we will be moving out collections calls to CRC. In March Sheena and Kinzey will be making the collection calls and informing customers of the new system. Nicki will also be putting information on the new collection process on social media. There will also be an insert in next month's bill. Director Weiler asked at what time the calls will be going out. He was worried that if the calls go out in the morning, customers will not be home. McWhorter was thinking the calls would go out during the evening time. They will look more into when the calls will be generated.

Legislature

McWhorter and Strehle listening to a hearing on the rolling blackouts that occurred in February. Mark Kirby presented testimony for rural electrics. Members on the call included SPP Manager, NPPD, OPPD managers and many senators. Discussion was mostly on the timeline of the blackouts. The senators wanted to hear from the top how we can improve the system if it is to fail again. Discussions were also held on Net metering and broadband.

NPPD

McWhorter had a phone call with NPPD and wanted them to know that we need to be more informed with how the situation was going. A list was created by NPPD during the rolling blackouts but was not followed. McWhorter would like NPPD and SPP to take more responsibility on the situation and have a plan in place if this situation would happen again.

NPPD also has a surplus of 94.7 million from February, 92.9 million of that was from production. There is a possibility of another PCA for the district for 2023.

Solar

Solar was not great in February, but it was a cold, gloomy month. March is already looking up from February. CCPPD has 4 solar projects in the que and several other customers that have contacted CCPPD about installations.

Bancroft Sub

The sub is very close to completions. This week the crew has been working on Sub T and taps.

COVID

80% of the employees at CCPPD have gotten their first vaccine. McWhorter is hopefully that vaccinations will allow a return to normalcy.
