In last month board meeting Director questioned the kWh estimates on the LED security lights and some of the discount rates. The discounted rates, McWhorter did some research, and the discount rates only bring the discounted account into line with the general rural service rate. There's about a \$1 difference in the monthly bill between discounted village account and rural accounts. With the LED lights, McWhorter got great information from NPPD on lights. In Policy 512, the changes outline a more accurate estimation for the lights.
